ELECTIONS HAVE CONSEQUENCES



By the time this article hits your **PRESIDENT** mailbox we will have a new president. Andy Tuttle While the NALC has enjoyed or suffered through various past American Presidents, President Trump is a whole

different breed of cat and we honestly have no idea how he views the USPS and those of us who have dedicated our

working lives to the post office. We can however, draw inferences from some of his choices for his cabinet.

One cabinet level department that the NALC will deal with is the Department of Labor. Mr. Trump has nominated fast food CEO Andrew Puzder to lead the department. The DOL exists to, "foster, promote, and develop the welfare of wage earners and job seekers", to "improve working conditions" and "assure work related benefits and rights".

To be sure, Mr. Puzder has achieved success in the business world. He took the moribund Hardees/Carl's JR. fast food franchise, boosted revenue and profits and made it not suck like it had before. However, he is being tasked with leading the department that exists to assist and advocate for workers, not managers, corporations, or CEO's. It is the Department of Labor, not the Department of Management.

What we do know based on Mr. Puzder's own words should sound alarm bells. He is a vocal critic of raising the minimum wage and his company and its franchisees have paid out millions to settle overtime violations and wage theft. Sound familiar? He is on record as stating that workers have too many protections such as mandatory breaks. He is also on record as an aggressive promoter of automation. He has stated that he prefers robots because they don't get sick and they don't complain. This is the man who will be in charge of protecting American workers.

The job of the Commerce Secretary is to promote economic development and raise American standards of living. Commerce nominee, hedge fund billionaire Wilbur Ross made a large chunk of his fortune in mining. He engineered buyouts that busted unions, cost workers their jobs, and cost retirees their pensions and benefits. He also owned the Sago mine in West Virginia where 12 workers were killed in an explosion in 2006 and numerous safety violations occurred. This is a striking choice when contrasted with Trump's campaign promise to improve the lives of American miners as well as other working Americans.

The GOP controlled Congress also has plans laid out in past actions and the party platform. We have seen much of this plan already on the state level and we are about to see it on the national level. This is not partisan exaggeration, this is a given. What we have seen on the state level where the GOP controls both the legislature and Governors mansion (Wisconsin, Michigan, and Kansas, for example) is the passing of right to work (for less) laws, eliminating prevailing wage laws, and the reduction and elimination of safety rules put in place to protect workers. What we do know for a

fact, not a made up fact but a real, provable fact, is that right to work laws do nothing to improve the economies of the state's where they have been enacted, they do not result in increased jobs or hiring but they do result in lower wages and less safe workplaces. Obviously everyone regardless of political persuasion is for more and better jobs. The question then remains; how are those jobs supposed to be good jobs if the workers' rights to organize for better wages, benefits, and working conditions is infringed? It won't happen. Every gain made in workers rights and standard of living has been earned through the struggle of those who toil. It was never gifted.

Here are some things that President Trump and the GOP majority are on record as supporting during the 115th Congress:

A hiring freeze in the federal workforce. It is unclear if the USPS is included in this freeze but any Letter Carrier who has been around for a while knows how damaging and demoralizing a hiring freeze is. The House Oversight and Government Reform Committee has made it clear a priority will be to make it easier to fire the "bad apples". Ever had a boss that had it in for you? You too could be characterized as a "bad apple" and without your due process protections there isn't much you can do except get your resume in order.

Reducing pay and increasing employee benefit contributions. The House voted to reinstate the "Holman Rule", resurrected after 130 years to weaken the Civil Service and the protections we enjoy under it. Lawmakers are targeting what they call "overcompensation" of the federal workforce. The 2016 House budget, authored by incoming Secretary of Health and Human Services Tom Price would force federal employees to pay an additional 6% of our pay towards our FERS retirement. That amounts to a pay cut of \$2000/ year for a Letter Carrier at the bottom of the pay scale and a \$3500/year pay cut for a Letter Carrier at the top of the pay scale. Can you afford a 6% pay cut? Do you feel like you're overpaid? I don't, so let your voice be heard!

Eliminating union business conducted on the clock. No fewer than 8 bills went before the now expired 114th Congress that all sought to eliminate official union business. These bills never went anywhere because President Obama would have vetoed them. If this passes the 115th Congress and is signing into law by the president, the ability of your Union officials to process and adjust grievances on the clock would be eliminated. What does that mean? It means that on top of the big pay cuts that some envision for us we would either have to pay a lot more in union dues to pay for the Union representation that protects us or hope like hell that we have some very dedicated people that will spend their own time processing grievances for all of us and do it for free.

It doesn't matter who you voted for in the election. We are all Union members and we are all part of the labor movement. We have a duty to be proud of this fact and identify ourselves as Union members to our elected officials. Even our most conservative members must acknowledge when our livelihoods are threatened and the organization that protects our livelihoods is under attack. When this happens we have an obligation to ourselves, our families, and our Brothers and Sisters to let it be known loudly that we disagree.

A lot of people voted for change but they didn't vote for a pay cut, reduced benefits, or greater burdens of healthcare costs. They didn't vote for the loss of our rights and protections in the workplace, or the loss of our jobs. America was made great because of Unions, not despite them. It makes no sense to believe that weakening Unions will somehow strengthen the position of wage earners. If our elected officials engage in this behavior we need to let them know they are wrong and that we will remember. Always remember that we can lose everything we too often take for granted with the stroke of a pen.

RETIREMENT: A GREAT CAREER!!!!



DIRECTOR OF RETIRED CARRIERS Mike Wamsley Retirement is what we are all working for! In my first column, I said that it was the first of several that will deal with how to retire. In the first, I talked about how to determine

if you are eligible to retire—for both the Civil Service Retirement System (CSRS) and the Federal Employees Retirement System (FERS). Both dealt with years of service and age. Next, I talked about how your pension is determined and how you can request an estimate, on Lite Blue, based on a specific month, starting on the first of that month. This was made with your High-3 Average Salary. Two other things that you need to remember before retirement deal with Flexible Spending Accounts and Uniform allotments. First, Flexible Spending Accounts: these accounts are a great deal for the letter carrier but only an ACTIVE letter carrier. Your participation for these accounts ends the day you retire. You can't use the account to pay for any medical or child care bills after your retirement date. You can still get reimbursed for all bills prior to you retirement. UNIFORM ALLOTMENT: you can use this up until 30 days prior to retirement unless you have stated the intent to retire before that. In that case, management may stop your participation in the program.

Just to remind you of a several things impacting your retirement, Military time. You may use active duty time to extend your federal service. The same goes for any other Federal Service. Both of these can be used to determine your years of service but only if you have paid the Social Security deposit. To pay the deposit, you need to contact USPS Shared Services and arrange that. There is a difference between CSRS and FERS on what is creditable

with Shared Services to see if you qualify for retirement. Unused Sick Leave is another item that can affect your years of service. Sick Leave can't be used to make you eligible to retire but once you are, Sick Leave can be added to your years of service for retirement. It is used in monthly increments. This is still true for those who have maxed out their years of service. It will be

added on after 41 years 11 months to give you a larger pension.

service so you need to check

Additionally, FERS participants who retire prior to age 62, can receive a Special Annuity Supplement. The FERS system uses the Social Security payment as part of their retirement program but if you retire prior to age 62, you usually can't receive this so this Special Annuity Supplement is added until your 62nd birthday. This supplement is paid for by OPM, not Social security.

CSRS participants may also receive a Social Security payment based on the number of credits accrued by paying Social Security taxes from your pay checks. However, you need to remember that you will have about 2/3 of you payment removed because you are a Federal Worker and subject to WEP, Windfall elimination Program. This act targets us as Federal Workers to keep up from taking all that we have paid for in the Social Security program.

Now that we have gone over all these items of eligibility, amount of pension, and other items that can affect your retirement, we will assume that we are going to retire. What do we do now? That will be the subject of my next column. What Actions Do We Take? Until then, keep on delivering for our customers. Here's hoping that you have a Happy 2017. Remember, the NALC is here to support and defend all our Sisters and Brothers. ON TO RETIREMENT!!!

FINDING THE UNKNOWNS

win the World Series. Wait a minute.....that already happened. This time of year always reminds me that baseball is the greatest of team sports. The game of baseball is also a great analogy to answer one of the most frustrating leadership issues that faces an organization's "older generation".

As I was winding down my active involvement in the NALC's leader-ship, I thought it was my responsibility to leave the union "in good hands". I was fortunate that President Tuttle was not only ready, but willing to assume leadership of our State Association. I had watched him grow into an outstanding unionist for years, and I was anxious to see what new heights he would lift our union to. In other positions, finding replacement officers that are ready isn't that hard. Finding replacement officers that are willing, however, is sometimes nearly impossible. That's where baseball comes in.

Most of the time, when I approached a next-generation union member about running for an officer position, the answer I got was "maybe someday, but I'm not ready yet." That attitude is perfectly acceptable if you are playing a sport like basketball. If younger teammates weren't quite comfortable taking the game-winning shot under pressure, the Chicago Bulls of my generation could always just pass the ball to Michael Jordan on every play. The same is true for this generation's LeBron James or Steph Curry. In football, my generation's Dallas Cowboys could just hand the ball to Emmitt Smith every time they needed one first down to run out the clock. This generation's Cowboys can now do the same thing with Ezekiel Elliot.

Baseball, however, is a whole different game. When your team is in the field, if the ball is hit to you, you can't hand your glove to someone else and say "you catch it!" If your team is batting, when your turn in the batting order comes up, you can't hand the bat to a teammate and say "you do it". It's all up to you to get the hit that wins the game. Babe Ruth may have been baseball's best hitter of all time, but he could only bat when his

turn in the order came up. If all the Yankees had was the Babe, they wouldn't have won very often. They won championships year after year because other

players did their jobs when their spot in the order came up.

Likewise, the NALC has never been successful because a few stars have made all the plays. The NALC has been a championship union for over a century because role players have stepped up to the plate when it was their turn in the batting order. Andy, Ike, Carol, Karen, Mike, Bob, Pat, Brad, Dave, Joan, and other proven NALC stars probably won't be there when that contract violation occurs. If you're the one that witnesses it, you have to pick up a bat and knock in the winning run. If our legislative antagonists drive a potential bill into a Congressional gap, you need to make the diving catch that says to them, "you're out!" Remember, you never know when the ball will be hit to you or when the winning run will be on base, so you have to always be ready when the situation calls on you and nobody else.

We are reaching that point in the Kansas State Association. Our locals have had the unbelievable good fortune to have been led by unionists who carried the championship banner for decades. Don't take the easy road and think "I'm not ready yet". When it's your turn in the batting order, step up and swing with all your might. That's how the Cubs finally won the World Series!

WHAT NOW?



STATE EDITOR Amanda Beckley To the surprise of many Americans, this "unpresidented" election finally came to an end with the President-Elect becoming Donald J. Trump. The

election is now history, but the

work of letter carriers for our

legislative agenda continues.

Labor Unions have fought tirelessly for decades to not only improve the lives of their members, but also the lives of everyday non-union workers. When unions bargained for better wage, the average worker benefitted with higher wages as well. When unions battled for a 40 hour work week and overtime pay, average workers were also rewarded with a 40 hour work week and overtime compensation. When unions labored for paid sick leave, paid holidays and earned vacations, the average worker won those benefits as well. It's easy to overlook the struggles of those that came before us as we reap the benefits of their hard work, determination and passion for raising the standards of living for the working class and their families, but it is now our time to dedicate ourselves to protecting our union benefits.

It appears from nominations and appointments made by the president-elect along with the GOP Platform approved at the Republican National Convention that our concerns, and sometimes fears, must be met with hard-work and dedication to protect our wages, benefits, and frankly, our right to collective bargaining. To be clear, let's take a look at the attack on federal employees in the GOP Platform. In the section titled, "Restoring the American Dream", here is what it says about the federal workforce:

The federal workforce is larger and more highly paid than ever. The taxpayers spend an average of \$35,000 a year per employee on non-cash benefits, triple the average non-cash compensation of the average worker in the private sector. Federal employees receive extraordinary pension benefits and vacation time wildly out of line with those of the private sector.

We urge Congress to bring federal compensation and benefits in line with the standards of most American employees. A Republican administration should streamline personnel procedures to expedite the firing of bad workers, tax cheats, and scammers. The unionization of the federal workforce, first permitted by Democrat presidents in the 1960s, should be reviewed by the appropriate congressional committees to examine its effects on the cost, quality, and performance of the civil service. Union representatives in the federal workforce should not be paid to conduct union business on the public's time.

This is opposite of what I personally believe, and I'm damn sure that I'm not overpaid. "Making American Great Again" should focus on ensuring more workers, not less, enjoy our securities: a living wage, health insurance, life insurance, savings plans, pensions, safe working conditions, paid holidays, paid vacations, paid sick leave, FMLA, and a grievance process, which brings me back to "Restoring the American Dream". The committee chairman of this sub-committee of the party platform was Andrew Puzder. Who is Andrew Puzder? Well, he is the president-elect's nominee for Secretary of Labor. He is the CEO of CKE Restaurants, known to you and me as Hardee's and Carl's Jr. He has publically stated that he opposes raising the federal minimum wage, the Labor Department rule which makes more workers eligible for overtime pay, paid sick leave and the ACA, also known as *Obamacare*, just to name a few. He disagrees with the issues that

labor unions covet and fight day-in and day-out to maintain and spread to other workers.

Brothers and Sisters, I don't care if you voted for Mr. Trump or not. The election is over, and we are facing a Republican House, Senate and White House. Whether you admit it or not, even though they have put it in print, there are forces within the Republican Party that would like nothing more than to strip us of our wages, benefits, union and service. We have the opportunity to gain support for letter carrier issues in Kansas with what will be two new members of the House. Roger Marshall will represent the First District and an unknown replacement for Mike Pompeo, who is nominated for Director of the C.I.A., will serve the Fourth District. Take a moment and either write or call your respective representatives and work hard to educate them on why our issues are America's issues.

The USPS is a goldmine in the eyes of a businessman. It is up to YOU to get engaged in the legislative process. Each one of us has given blood, sweat (lots of sweat) and tears to this job and the citizens of this country. Let's make sure our retirees maintain a decent standard of living, our retirement remains achievable, and the future of the NALC strong.

Stay Safe and stay informed.

Speaking to <u>Business Insider</u> in 2016, Puzder said that increased automation could be a welcome development because machines were "always polite, they always upsell, they never take a vacation, they never show up late, there's never a slip-and-fall or an age, sex, or race discrimination case."

As Republicans, we oppose tax increases and believe in the power of markets to create wealth and to help secure the future of our Social Security system. Another Measurement Tool – The Postal Service has now come up with another tool (PET) to measure a letter carriers workload on a daily basis. This one, like the others before it, is accurate according to management. This one, like the others before it, is based on data which management feeds into a computer. If they've all been so accurate, why do they keep reinventing the wheel? I've received calls from numerous offices that management has stated that the NALC was made aware of, approves and supports the new program. For the record, we don't approve or support it. If management wants an accurate estimate of a letter carriers daily workload, all they have to do is ask the letter carrier. For more information, read the CAU Time and Standards article in your November Postal Record.

Carrier Academy – The new Carrier Academy is finally up and running. CCA's are entering the workforce with at least a basic understanding of what being a letter carrier actually means. I'm hopeful that the new Academy will lower the 54% turnover rate we currently have which will be beneficial to both the NALC and the Postal Service. Having said that, the transition to the new Academy hasn't been seamless. There have been difficulties which have been compounded by some stupid decisions from the service. However we have been able to work through most of these issues and where we haven't, we have forwarded the issue to the parties at headquarters. I'd like to thank the lead trainers in each of our four districts, Stacey Finnegan – Central Plains, Derrick Williams – Gateway, Kelly Strottman – Hawkeye, and Steve Diamond – Mid America, for their time and effort.

NALC History – Free city delivery was established in 1863. Letter Carriers worked 7 days a week and 10 to 12 hours per day. In 1888 letter carriers banded together and achieved an 8 hour day through legislation (even then we needed to lobby congress...LCPF anyone). In 1889, 60 letter carriers arrived in Milwaukee and these delegates passed a resolution which officially established the National Association of Letter Carriers. In 1893 the NALC went all the way to the Supreme Court of the United States to enforce the 8 Hour Law and carriers were eventually awarded \$3.5 million dollars in overtime claims. Nearly 125 years later, management still can't manage overtime....to be continued.

Cold Weather – Seasoned letter carriers are well aware of the dangers involved with delivering mail in extreme cold weather. Frostbite is too often the result of not being prepared for the conditions or of the rapidly changing weather even during a single day. To you seasoned letter carriers, please reach out to your brother and sister CCA's and make sure they understand how to protect themselves against the cold. The USPS also has responsibilities to protect its employees and should implement safe work practices which include: Providing proper tools and equipment; Scheduling workers in the warmer part of the day; Avoiding exposure to extremely cold temperatures when possible; Limiting time outdoors on extremely cold days; Providing warm areas for break periods; providing warm liquids; Monitoring workers who are at risk of cold stress; Monitoring weather conditions and having a reliable means of communicating with workers and being able to stop work when necessary; Acclimatizing new workers and those returning to work from extended time off, including more frequent breaks in warm areas. These are just a few of the recommendations of OSHA. A complete discussion of employer responsibilities as well as safety tips for workers can be found at the Department of Labor website: https://www.osha.gov/dts/weather/winter_weather/beprepared.html
